### II APPROVAL OF MINUTES – March 2, 2011

## IV PRESENTATION BY DIANE ARANDA, PROGRAM MANAGER WITH THE CALIFORNIA ENDOWMENT, ON BUILDING HEALTHY COMMUNITIES INITIATIVE IN RICHMOND

**Diane Aranda** gave an overview of the California Endowment – Building Healthy Communities in Richmond. Over the last 14 to 15 years, they have funded a range of efforts related to community health. Their plan includes a 10 year commitment to work closely with 14 communities throughout California to improve community health, specifically, health for children and youth. Richmond is one of the communities they will be working with. They will be looking to change outcomes for kids and families living in targeted neighborhoods that include, North Richmond, Iron Triangle, Belding Woods, Coronado and Pullman.

**Commissioner Bautista** asked the source of their funding. **Ms. Aranda** said they are a private foundation that started in 1996 when Blue Cross converted from a nonprofit to a for profit company. When that happens, the State of California assures that their assets go back to support the public. Those assets created the California Endowment and the California Health Care Foundation.

Commissioner Hunziker asked how the neighborhoods were selected and how they plan to keep families safe from violence, which is their 2<sup>nd</sup> priority outcome in the handout. **Ms. Aranda** said they looked at the communities where the need was greatest as far as poverty and other socioeconomic factors. They also looked at places where they thought there was leadership and places where there was a track record for change and a willingness to partner and embrace their agenda. They plan on working with youth and families to build and support greater collaboration and engagement of communities and neighborhoods working together with other key institutions to have a shared vision of what needs to happen. They will also be looking at family violence, re-entry and gun violence.

**Commissioner Bautista** asked what their strategy was as far as reaching out to the ethnic community in Richmond.

**Ms. Aranda** said they will be engaging a number of organizations that have strong ties to varied ethnic communities. They will be looking at a range of communication strategies that include going door to door and various media outlets, community groups, schools, churches, neighborhood councils, etc.

**Commissioner Bautista** suggested that they hand out brochures at the Cinco de Mayo Festival. **Ms. Aranda** said they are considering that.

### **V** REPORT OF CHIEF OF POLICE (Chris Magnus or his representative)

A. Report of recent activities, events, incidents, and related matters

**Chief Magnus** talked about how they are dealing with waves of retaliatory violence. Capt. Gagan gave an update on how they are handling the situation. He said they are closely communicating with property managers, tenants, ONS, as well as local law enforcement agencies. They are putting more officers on the streets, especially on weekends. The officers that are working foot and bike patrols are modifying their hours. There are also officers on dirt bikes patrolling parks. There will be an event on 4/23/11 that is being put on by Pastor Washington from Operation Richmond called "Make Noise for Peace." It will be a caravan that will go from the Harnetts through the hotspot neighborhoods, then along So. 2<sup>nd</sup> Street and into the Central District. They will forward information regarding the event to the Police Commission. Chief Magnus briefed the commission on another long term strategy they will be using called Cops & Kids. It is a training program that will instill better relationships between cops and young people that is sponsored by the Fred Rogers Foundation and Office of Juvenile Justice and Delinquency Prevention. He said he worked with Lt. Booker and Sgt. Dickerson on a proposal to bring the training to Richmond. Richmond was one of the cities selected to do this training. The program will start this summer. The Chief reported that they have a Regulatory Unit that will enforce requirements for the sale of alcohol, cigarettes, medical marijuana, smoking ordinances, etc. It is a four person unit led by Capt. McBride. Sgt. Cappiali will oversee another police officer and two civilian employees. Chief Magnus said they will be providing Active Shooter Training for elected officials, policy making boards and volunteer boards. He provided a handout – Civilian Management Response Guide for an Active Shooter Event. He also provided information on updating the city's noise ordinance. Chief Magnus also commented on the recent news regarding the Explorer Program. He said they are committed to making sure the Explorers are getting the attention, leadership and support that they need. He said the case is being investigated internally and also by the DA's office and several federal authorities.

**Commissioner Bautista** asked for information regarding Cinco de Mayo. Capt. Gagan said the parade will be at 10:30 on Saturday, April 30<sup>th</sup>, with 23<sup>rd</sup> Street closing down on Friday April 29<sup>th</sup>. The festival will be on May 1<sup>st</sup>.

B. Briefing on policy regarding impounded vehicles of unlicensed drivers

Chief Magnus said they have a policy that was put in place over 1-1/2 years ago. If a vehicle is stopped for traffic safety or sobriety checkpoints and the driver does not have a driver's license, they will allow the person to park their vehicle or have another licensed driver transport them and their vehicle to their final destination. They will get cited but the vehicle is not towed. If the license is suspended or revoked, or the driver is drunk, the car will be towed. He said the policy is working well.

Suggested showing PSA in government classes. She is drafting a letter to PTA president at the elementary and middle schools requesting to give a presentation for next school year. She is working with Crime Prevention on #4I (Organize "Coffee with a Cop") & 4K (Organize small, spur of the moment community gatherings with beat officers).

**Commissioner Hunziker** suggested that #3E (Ask RYSE Center to develop a PSA directed at Youth), be done first, then #3D (Air PSA on KCRT) & 3F (Engage Youth media Academy at Richmond HS) could take place. **Commissioner Roberson** suggested that KCRT film RYSE and high school kids creating PSA then that could be used in all other projects.
